MUNICIPAL ORDINANCE

CHAPTER

An Ordinance relating to Fire Department Fees

Be it ordained by the City Council of the City of Haverhill that Document 87 of 2000, Document 141 of 2003, and Document 133 of 2004 as amended, is hereby further amended by the following:

Increase in Fees - Effective Upon Passage -

Fire Alarm System:

- a. Install or Repair - Residential \$ 25.00
- b. Install or Repair - Commercial less than 7,500 sq. ft. \$ 50.00
- c. Install or Repair - Commercial over 7,500 sq. ft. \$100.00

Be it ordained by the City Council of the City of Haverhill that Document 87 of 2000, Document 141 of 2003, and Document 133 of 2004 as amended, is hereby further added by the following:

Smoke Detector Inspection (per M.G.L. Chapter 148 Fire Prevention, Section 10A):
(for combination smoke/carbon monoxide inspection)

- a. Single family dwelling or a single dwelling unit: \$ 50.00
- b. 2 family dwelling: \$100.00
- c. Any building/structure with 6 or fewer residential/commercial units: \$150.00
- d. Any building or structure with more than 6 units: \$500.00

Carbon Monoxide Detector Inspection:

Per Unit \$ 25.00

False Fire Alarms/Sprinkler Activation:

Any Sprinkler or Fire Alarm contractor and/or company working on a system without proper notification to Fire Alarm shall be subject to the following:

- a. First alarm per year: No charge
- b. Second alarm per year: \$50.00
- c. Each subsequent alarm or more each year: \$200.00

Open Burning Permit:

1st Offense -- Illegal burning \$ 25.00
 2nd and each subsequent Offense -- Illegal burning \$ 50.00
 \$100.00

Agricultural Burning Permit:

1st Offense -- Illegal burning \$ 50.00
 2nd and each subsequent Offense -- Illegal burning \$ 50.00
 \$100.00
